AGENDA ITEM: **REVIEW AND DISCUSS THE PROPOSAL TO RENAME SEVERAL STREETS IN THE HIGHWAY 29 CORRIDOR**

ACTION REQUESTED: Ordinance Resolution Motion Receive/File

The 29/41 reconstruction has had a dramatic impact on the local roads in and around the 29/41 interchange. The project will cause some of the local roads to be “cut off” and will also cause the creation of new roads. The Village will need to consider the naming of the new roads that are being constructed, as well as the old roads that are no longer connected. Attached is a map of the area in which the majority of the impacts will be felt.

To start the process, staff would recommend renaming C.T.H RK and Ullmer Road (Section F) and the short Road (Section M) that comes off of Ullmer Road to Badgerland Road and Badgerland Court. The Road extends from Riverdale Drive to Taylor Street. It lines up with Badger Road in Green Bay.


Reommended Action:






