Subject: Eagle Scout Congratulation Letter – Cody Allan Destache

We would be greatly honored if you send a letter of congratulations for Cody Destache on his achieving the rank of Eagle Scout with the Boy Scouts of America. Cody is an active member of Boy Scout Troop 1113, Bay Lakes Council of northeast Wisconsin. Cody will be recognized for his achievement in an Eagle Scout Court of Honor on Saturday, June 16, 2012.

Cody earned his Eagle Scout rank and badge through completion of a service project in partnership with the Wisconsin Department of Natural Resources -NE Regional Headquarters in the Village of Howard. Cody's Eagle service project involved planning, organizing, and directing the construction of a 20' x 10' handicap accessible pedestrian bridge over a ditch for the DNR's Prairie Restoration Project on the headquarters property. The bridge will be part of an educational Interpretive Walking Trail, which will focus on identification of prairie plants native to Wisconsin. As part of the project, Cody worked closely with DNR staff, including DNR Engineer Randy Douglas on designing the bridge to ensure that it met state standards. He followed through with ordering the required lumber and other construction materials. Cody concluded the project by leading fellow Scouts and adult volunteers in construction of the bridge which included site preparation, measuring and cutting the lumber to size, placement of the pilings and support structure, laying of the deck, and installation of safety railings.

Cody is currently a senior at Bay Port High School. He plans on attending the University of Minnesota – Morris, MN in the fall of 2012 studying biology and playing football.
