

Hi Jon,

I spoke to you last week about having a 5k Run/Walk at Meadowbrook Park to help kickoff the picnic at St. John the Baptist Church. Attached is the registration form and information regarding the run/walk. The run/walk is scheduled for **Saturday July 14th at 8:30am** and will run until about 10:30am. We will begin and end the race in the parking lot area by the baseball field/retaining pond area.

The walk will continue through the trail to Cardinal Lane, then down to the YMCA, back to the United Healthcare building and then back to Meadowbrook park. All participants will be required to stay on the sidewalk at all times and not cross the street - this is the same route we used when we held the run/walk in previous years without any issues. We will not be using any picnic tables or facilities at the park, we just wanted to use the path.

Last time we had about 80 participants. We also had a kid's fun run which was held on the gravel path behind Meadowbrook school which we would like to use again this year. If there is anything else you may need, please let me know!

We plan on starting to advertise the walk/run soon so if there are any concerns or if the village does not approve our walk/run please let me know as soon as possible.
